FAQ: Fall 2021 Student COVID-19 Vaccine Incentive Program

What are the eligibility requirements for the \$300 Fall 2021 Student COVID-19 Vaccine Incentive Program?

There are two eligibility requirements:

- First, you must be a currently enrolled Chaffey student who enrolled for your fall 2021 semester courses on or before September 7, 2021. If you enroll in your fall 2021 courses after September 7, 2021, you are not eligible for the current COVID-19 Vaccine Incentive Program; and
- Second, you must submit valid documentation through <u>MyChaffey Log In</u> by no later than October 15, 2021, showing you have received either: (1) both of the two-dose mRNA series (Pfizer or Moderna) COVID-19 vaccinations; or (2) the single dose of Johnson & Johnson's Janssen COVID-19 vaccine.

What does "valid documentation of your COVID-19 vaccination" mean?

Valid documentation of COVID-19 vaccination for the purposes of this incentive program means the completed Center for Disease Control Vaccination Record Card issued as part of the COVID-19 vaccination process.

How do I submit my proof of COVID-19 vaccination?

1. Submitting proof of COVID-19 vaccination is easy! Students can submit via the MyChaffey Log In.



2. Once logged in, you will see a box with instructions on how to submit your proof of vaccination.

If I already submitted my proof of COVID-19 vaccination, do I need to resubmit to get the incentive?

No. Students only have to submit proof of COVID-19 vaccination once.

What if I have already received both of the two-dose mRNA series (Pfizer or Moderna) COVID-19 vaccinations or the single dose of Johnson & Johnson's Janssen COVID-19 vaccine? Am I still eligible for the \$300 Vaccination Incentive?

Yes. If you are a current fall 2021 Chaffey student who enrolled in your fall 2021 courses on or before September 7, 2021 and you submit proof of your vaccination by October 15, 2021, you are eligible for the incentive.

How and when will I get the \$300 COVID-19 Vaccination Incentive?

Chaffey College will provide the \$300 COVID-19 Vaccination Incentive to students through a cash gift card or direct payment. Fall 2021 students should anticipate payment in December 2021.

What if I registered for courses after September 7, 2021 and I am not eligible for this Incentive Program, will I be eligible for a future Student COVID-19 Vaccination Incentive?

If allocated funds are still available, the College may offer future student COVID-19 vaccination incentive options.

Students who participate in the Fall 2021 COVID-19 Vaccine Incentive Program are not eligible for any future Chaffey COVID-19 Vaccine Incentive Program.
