# Measure P Funding Update Summary:

- First Bond Issuance Resolution
  - \$200 million; Receipt of bond proceeds on September 24, 2019
- Refunding Resolution (Measure L)
  - Refunded \$50 million+, saving taxpayers over \$6 million on their Measure L tax bills


## **Consultant Procurements (Program Level):** None pending Phase 1 Project Work Update:

- Rancho Cucamonga campus:
  - New Library/Learning Commons Project Increment 1 construction (sitework and utilities) started July 2023, at 95% completion. Increment 2 (building) package) construction started and is ongoing. Added scope for campus underground electrical upgrade work, started and ongoing.
  - MACC Renovation Project All 2<sup>nd</sup> floor occupants relocated to make-ready for construction start. Project rebid process is underway, rebid necessary due to first attempt over architect estimated cost for the project. Approvals for an award for contract planned for June 2024 Board meeting.
  - Swimming Pool Renovation Project Buildings CMU; steel; interior framing; and rough mechanical, electrical, plumbing at 80% completion. Roofing work to follow. Canopy steel installation work is ongoing, bleacher foundation and steel work to follow.
  - Campus-wide Boiler Retrofit Project Contractor working at fourteen different new boiler locations, four Boilers are operational at new location. Boiler equipment for the entire project procured.
- Chino campus:
  - Chino IB Project Mechanical, electrical, plumbing, fire sprinkler work, exterior wall stucco, and metal wall cladding installation at 90% completion. Internal drywall at 99%, and glazing and storefront at 80%. Project completion delayed for two major elements a) material procurement with supply chain delays, and b) excess wet winter weather impacts on the project schedule.
- Fontana NEW campus:
  - Phase 1 Project: All four Design-Build Entities (DBE) proposals received for the project were rejected, a revised Request for Proposals (RFP) will be issued to all eight qualified firms. A contract for the selected DBE is planned for Governing Board approval in June 2024.
- **Ontario NEW campus:** 
  - Ontario Master Plan received Governing Board approval in December 2023. Request for proposals for Design-Build Criteria Architect services selection is underway, as well as CEQA-EIR review and process options.
- ADA Barrier Removal Project for Rancho Cucamonga and Chino campuses:
  - Rancho Cucamonga campus:
    - Phase 1 and 2 site area work projects Construction ongoing at 11 different locations on campus, 3 locations are complete and operational.
    - Phase 3 building work projects DSA approvals received for the project, next steps in consideration.
  - Chino campus:
    - Phase 4 Project DSA approval received, next steps strategy discussion ongoing. Waiting for off-site work access approval, more to come.
