• **Motion for Discussion** - Senator Johnson moved to discuss the STSW. Senator Boboye seconded the motion. Time for discussion was extended 5 minutes.

Senator Johnson reviewed past issues brought up in this group. Senator Doget brought up questions that have arisen in regards to faculty senate representation, penalization of smaller programs when retirements occur, and workgroups in competition. Senator Chamberlain recommended framing in terms of student success. Discussion of mutual agreement and collegial consultation in AP/BP 2510. Senator Henry mentioned campus culture in terms of communication approaches from administration in order to grant respect to discipline experts to address major gaps. Senator Chamberlain asked which committees should be or have been involved in this type of discussion.

• **Motion for Discussion** - VP Encarnacion moved to discuss the candidates for the Evaluation Forms Committee. Senator Jenkins seconded the motion.

VP Encarnacion advocated for Sharon Alton due to her extensive DEIA experience. Senator Lee advocated for Angela Cardinale since DE plays a big role with so many online classes currently offered. Senator Marcus advocated for Jackie Boboye due to her being fair, reasonable, and uses good judgment. Senator Chamberlain also supports Sharon Alton due to DEIA experience which is included in the new contract. Senator Ith notices culturally sensitive gaps to which Sharon Alton can bring expertise. Senator Boboye expressed desire for counseling faculty to be part of this process and that she has DE work experience and prior experience in the Evaluation Forms Committee. Senator Holdiness advocates for STEM representation since both Angela and Sharon are from the English Department. Guest Lousia Villeneuve is interested in getting more involved and noticed DE assessment gaps in the evaluation form.

 - General Rules of Debate (partial)
 - Members may only speak if recognized by chair
 - All discussion must be relevant to motion/item
 - Members may speak up to twice on a motion/item
 - Each time, members may speak up to 10 minutes
 - Members that have vet to speak in a motion/item have preference
 - When possible, alternate between pro and con speakers
 - o Basic Process for Motions
 - Member obtains recognition of the chair
 - Member makes a motion
 - Motion must be seconded by another member
 - Chair states the motion and opens debate
 - Maker of motion may speak first in debate
 - Debate ensues
 - Chair puts the question, aka facilitates the vote
 - Chair announces the results
 - Note: Brown Act requires all votes be listed in the minutes
 - Request for Information, Parliamentary Inquiry, and Point of Order
 - Request for Information
 - Inquiry as to the facts affecting the business at hand
 - Parliamentary Inquiry
 - Request for the Chair's opinion on a matter of parliamentary procedure as it relates to the business at hand (not a ruling)
 - Point of Order
 - May interrupt the current speaker if timely
 - Member calls attention to a violation of the rules of the assembly
 - Must be raised promptly at the time the breach occurs

Academic Senate seeks two faculty to appoint to the Evaluation Forms Committee.

The description of this committee can be found in Article 20.4 of the 2023-2026 collective bargaining agreement and is also shown below:

"A standing evaluation forms committee shall consist of eight (8) persons: four (4) appointed by the District, two (2) appointed by the Academic Senate, and two (2) appointed by the Association.

Consistent with the provision of this section, the committee will review and recommend appropriate revision(s) to the forms and procedures for evaluations covered in this Article and Section 18.5.5. (l). Any revisions to the evaluation forms and recommended improvements to the evaluation procedures shall be subject to review and approval by the District and Faculty Negotiating Teams prior to their implementation."

• Angela Cardinale:

I want to contribute to the DE aspect of evaluations forms, particularly around RSI, accessibility, and equity. This is essential given the volume of DE course offerings and the new contract language. I have taught for 18 years in all modalities and am currently DE Coordinator. Also, I love forms!!!

• Sharon Alton:

I have been involved in groups to better support students/faculty. Because of my work on the DEIA Projects (Men of Color Task Force, SEPI, GP, PD-workshops, and the Contract DEIA workgroup), I feel my presence is needed on the evaluation-forms-committee to ensure that Chaffey is aligning to larger Equity goals.
