# NameCoach: Canvas & Outlook Integration

A person's name is part of their cultural identity; accurate name pronunciation builds toward an inclusive learning environment.

### **Benefits**

Namecoach provides your recording to members of the campus community though Canvas so others may verify they are addressing you correctly.

Namecoach also provides a public profile and recording URL allowing you to share it anywhere you feel is appropriate.

- Personal websites
- Project presentations

### **Optional**

If an individual chooses not to participate, they simply do not have to record their name - using Namecoach is optional.

Individuals can opt-out or in or change the recording, at any time.

### Respect

According to Race Equality Matters, 73% of people have had their name mispronounced, and 43% said it made them feel disrespected, 30% found it upsetting and 21% said it made them feel they didn't belong.

## NameCoach Canvas Integration

From the 24-25 STAC order form, there are two pricing options:

- \$1.00 per FTES (Chaffey cost would be \$14,647)
- An additional \$3,000 flat rate for the Outlook integration (optional)



I am seeking Academic Senate's formal endorsement of the NameCoach Integration tool in Canvas and Outlook as a way to foster inclusive teaching practices, demonstrate inclusivity, and highlight Chaffey's mission in valuing identity and individualism in students from a cultural and ethnic lens.

In doing so, I am also seeking the support from Academic Senate in coordinating conversations with administration to discover which funding areas can be negotiated to include this tool in a sustainable and on-going basis.

On December 4 2024 I attended the Dialogue with the Board meeting on behalf of Nicole DeRose.

To my understanding, CCFA has originally brought this idea forward to management through Labor Management Committee (LMC) meetings as a way to provide employees a neutral third party platform to discuss concerns, conflict, or other interpersonal disagreements that fall outside the more formal process established through Human Resources or Contractual Agreements.

The topic of Ombuds was brought forward to the Dialogue with the Board to continue the conversation. I stated that Ombudspersons had come up informally in Academic Senate in past years, but would bring the topic forward to Academic Senate in order to further discussion through our formal process.

In preparation for the Academic Senate's exploration of this topic, I have compiled relevant resources on ombudspersons. However, additional research by Representatives is encouraged to ensure a comprehensive understanding of the concept and its potential implementation.

- 1. San Mateo County Community College District Office of the Ombuds
  - a. Clear distinction from Title IX Coordinator
  - b. Concise "what the office can/cannot do" statements.
  - c. Seems to be close to what CCFA and Leadership may be interested in pursuing?
- 2. International Ombuds Association
  - a. Video overviews on what an ombuds person can do for an organization (including higher education)
  - b. Resources for High Education Institutions
  - c. Resources for starting an Ombuds office
  - d. Ombuds Office Best Practices, which includes Standards of Practice and Code of Ethics frameworks
- 3. Additional California Community Colleges where I could find Ombuds Offices (much broader application at CSU/UC level):
  - a. Santa Monica College
  - b. West LA College
  - c. Santa Rosa Junior College

Additionally, questions were raised by Governing Board members concerning cost for an ombudsperson, location of where the ombuds office would be, and financial support. Pomona College Ombud's is an example of where the Ombuds person is considered a part time employee, on campus twice a week, and messages can be left that they will return when not available. This would allow for flexibility within the structure of financial investment from the side of the college, when and if conversations continue forward.

# CalGETC and Common Course Numbering (CCN)

Academic Senate Update Angela Burk-Herrick January 2025

### Student Transfer Achievement Reform Act

Assembly Bill 928 (Berman, 2021)

Intended to simplify the transfer process for community college students so more students transfer and earn bachelor's degrees.

- CalGETC [1] Mandates the creation of the California General Education Transfer Curriculum (Cal-GETC), the singular general education transfer pathway that satisfies lower division requirements of both the University of California (UC) and California State University (CSU). (effective 2025-26)
- Requires automatic placement of students on an ADT pathway if students declare a goal of transfer and their stated major pathway exists and is offered by the college, with limited exceptions for students to opt out of the ADT placement (effective August 2024)

### **Common Course Numbering (CCN)**

Assembly Bill 1111 (Berman, 2021)

### Amends Ed Code SEC.2. 66725.5. (a) (1)

To streamline transfer from two- to four-year postsecondary educational institutions and reduce excess credit accumulation, on or before July 1, 2024, both of the following shall occur:

- A. The California Community Colleges shall adopt a common course numbering system for all general education requirement courses and transfer pathway courses.
- B. Each community college campus shall incorporate common course numbers from the adopted common course numbering system in its catalog


### GOAL: system-level articulation from CCCs to universities using CCN Course Templates

### 2. CALL TO ORDER (12:35 P.M.)

### 2.1 Land Acknowledgement

With respect and honor for the lands where Chaffey College resides and the leaders who came before us, we would like to take a moment to acknowledge the Gabrieleño-Tongva (GABRIEL-EN-YO TONG-VAH) Peoples, the original stewards of these sacred and unceded homelands. The Tongva people's history, language(s), cultural traditions, and legacy continue to shape this region and we recognize their continuing presence in their homelands.

**2.2 Attendee Identification** (Chino and Fontana Senators, cameras must be on and turn off all virtual backgrounds.)

### 3. PUBLIC COMMENT (Reserved for Guests only and limited to two minutes.)

- Laura Picklesimer read the following statement:
  - As a recently evacuated resident of Sierra Madre, I'd like to provide a statement on the LA county wildfires. In the past week, the Eaton and Palisades fires have destroyed 12,000 homes and businesses and have claimed at least 24 lives. 150,000 California residents were under evacuation warnings this weekend, ready to flee their homes at a moment's notice. My neighboring city, Altadena, was reduced to smoking rubble in what Governor Newsom is calling the largest wildfire disaster in American history.

During this time, members of the Chaffey community received no tangible support from the administration beyond links to some general resources for students, and nothing for employees was provided beyond the directive to call HR if they have questions. Appreciation goes to CCFA representatives for providing a few resources specific to the emergency at hand. It was not until six days later that anything approaching recognition of the magnitude of recent events was communicated by the executive team via email.

We should not assume that every Chaffey student or employee lives safely within district boundaries. Those in the extreme affected areas like myself may be displaced, may still be without power, gas and other utilities, may lack safe drinking water, and may risk daily exposure to arsenic, lead, asbestos and other carcinogens. And this disaster is still not over.



San Bernardino's neighboring county has been forever altered, and a greater recognition and sensitivity toward the lives affected would be appreciated from the campus community as a whole. I encourage Faculty Senate to refrain from addressing this disaster with a few quick words tacked onto a welcome back message.

The exact causes of the fires may still be under investigation, but the conditions of the disaster were exacerbated due to the current climate crisis. The Faculty Senate approved a climate change resolution in 2022 committing itself to addressing the ongoing climate emergency. Chaffey College's Rancho campus where I speak now sits less than two miles away from the same forest that, when ignited, decimated an entire foothill community. The threat is real, it's growing, and just because it occurred 30 miles away does not mean the college can't begin initiating real conversations about recent and possibly future disaster events.

Since the executive team has not shared any resources specific to the fires, I am providing a list of links to the senate for any Chaffey members who may be affected. Thank you.

- Angela Cardinale read the following statement:
  - Since Matt Morin no longer works at Chaffey College, and the executive team hasn't acknowledged the incredible work he's done, I wanted to publicly recognize it here. Matt is one of the most brilliant, most compassionate, and hardworking people with whom I've ever worked. We worked together for several years in both work experience and Distance Education. Without him, digital credentialing would not have happened at Chaffey College, though I also acknowledge the excellent work of Trelisa Glasatov and Laura Picklesimer in that work. I believe digital credentialing is the future of higher education and we could've been a national model for that work. It is a shame that our executive team didn't seem to understand this. Many people don't know that Matt also did amazing policy work at the state level, writing SB 554 and improving California's Benefit State-Defined process. Both of these ensure increased access to higher education and financial aid for two of the state's most vulnerable populations—undocumented adults who did not have access to high school and adults who did not graduate high school. Our College responded by telling Matt he could no longer work on these types of policies. Matt also deserves the credit for the success of our dual enrollment program.

Secondly, I want to encourage everyone to read this week's resignation letter of DelVonte Deary, who until yesterday was the Director of Network and Systems Integration. His letter details the very same patterns of problematic hiring practices and toxic work culture that our Vote of No Confidence spoke to. DelVonte was offered money by Susan Hardie to not share what he experienced and he turned this down.



I find it insulting that the Governing Board responded to our vote and our pleas for support with a collective shrug, and Dr. Shannon outright told us he doesn't care about our widespread concerns. Thank you for your time.

• Sadie Grantham first paused to acknowledge all that was just said, and thanked Laura and Angela for sharing. Sadie then introduced herself as the new Director of Student Activities. She drove in this morning past a fire and had to turn off the air conditioning because of the smoke getting into her car. Sadie acknowledged being here as a result of some of the hiring practices mentioned earlier and so she feels it is really heavy at this moment. Sadie wants us to know that she hears all of what we are saying and hopes to have an opportunity to meet with and to collaborate with everyone. Saide says she is happy to be here and hopes she can be a representative of administration who is in support and in community with us all. Sadie looks forward to working with everyone.
