Resolution on Equity Center & Conversion of Old Library

Whereas the construction of the new Library / Learning Commons is anticipated to be completed in November 2025,

Whereas Black and African-American students, Latine students, queer, trans, non-binary students, and students who are undocumented have been disproportionately targeted by the rhetoric and <u>executive</u> orders of the Trump administration,

Whereas Chaffey College is <u>committed</u> to being "an equity-driven college that fosters success for all students," and two of the college's <u>core values</u> are a "climate of inclusion and respect" and "dynamic student services,"

Whereas the MacKenzie Scott Donation provides <u>financial resources</u> allocated to "enhance holistic support services for our most vulnerable students,"

Whereas Chaffey College is a federally recognized <u>Hispanic Serving Institution</u>, but there is no dedicated space for students to explore their Latinidad identity and cultural wealth,

Whereas, the <u>Umoja</u> program has demonstrated significant student success rates propelling it to be leading equity initiative at Chaffey College while still not having dedicated staff or physical infrastructure to keep up with its continued growth,

Whereas student usage of the CCSJ and PRISM has grown exponentially since their openings, and students who use those centers have been asking for larger spaces to gather and attend events,

Whereas, <u>research</u> demonstrates the <u>effectiveness</u> of such individualized spaces for Black, Latine, and LGBTQIA+ students that have yet to be established at Chaffey College,

Be it resolved that the Chaffey College Academic Senate hereby requests that the existing, old Library building be converted into the Henry D. Shannon Center for Equity & Inclusion.

Be it resolved that during its use as a swing space for other construction projects, the building should house individual student centers catering toward the unique needs of each group, while emphasizing intersectionality, collaboration, and inclusion by hosting the various support resources and programs in close proximity.

Be it resolved that the most vulnerable student groups necessitating these individual spaces are Umoja, Latine / Puente, Rising Scholars, LGBTQIA+, and Undocumented students.

Be it resolved that this center would also be a legacy to honor Dr. Shannon's tenure as one of the longest-serving presidents of a California community college.

• Rose Ann Osmanian read the following statement:

As a member of the new Ontario Campus workgroup, I want to raise a concern shared at yesterday's meeting: the new campus currently has no plans to include a dedicated Success Center space. At the same time, the campus is being described as a "one-stop" site for students—implying they'll have access to the same support services as at any other Chaffey campus.

Ontario is being positioned as a hub for engineering, drafting, and cybersecurity—programs whose course maps include transfer-level English and math courses with built-in Success Center requirements. When I asked how students at Ontario would meet these requirements, the response from administrators was that students could, quote, "drive five to six miles" to the Chino campus.

But for many students, this isn't so simple. A bus ride between Ontario and Chino can take at least an hour, and not all students have access to reliable transportation. While I know that many of the Success Center services are available online, I am aware too that in-person math tutoring in particular remains in high demand—especially for students in STEM and MIT programs, which are math-heavy by nature.

Finally, I want to emphasize that each of Chaffey's campuses exists to serve students who live nearby, regardless of where they enroll in courses. As someone who works in the Success Center program, I probably carry a bias, but I do find it troubling that our non-Rancho campuses continue to be treated as



secondary. I genuinely welcome your perspective on this issue and hope we can find a solution that reflects our shared commitment..
